

**TOWNSHIP OF MANALAPAN**

**Ordinance No. 2016-08**

**AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 33, “POLICE DEPARTMENT,” SECTION 33-1, “ESTABLISHED”, OF THE CODE OF THE TOWNSHIP OF MANALAPAN, PERTAINING TO THE TABLE OF ORGANIZATION OF THE MANALAPAN POLICE DEPARTMENT.**

**Section I**

**BE IT ORDAINED** by the Township of Manalapan committee of the Township of Manalapan, County of Monmouth, and State of New Jersey that Chapter 33 “Police Department” be and is hereby amended and supplemented as follows: (Text removed has ~~strikes~~ and Text added is underlined)

**33-1 Established.**

The current number and ranks of sworn members of the Police Department shall be modified and adjusted:

6 <u>8</u>	Sergeant

C. Permanent Table of Organization

<b>Maximum Number</b>	<b>Position</b>
7 <u>9</u>	Sergeant

**Section II**

**SEVERABILITY**

If any section, subsection, clause or phrase of this Ordinance is held to be unconstitutional; or invalid for any reason, such decision shall not affect the remaining portions of this Ordinance.

**Section III**

**REPEAL**

All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency.

**Section IV**

**EFFECTIVE DATE**

This Ordinance shall take effect upon due publication according to law.
