CAPITAL ORDINANCE NO. 2017-13**

**CAPITAL ORDINANCE PROVIDING FOR PRESSURE FILTER IMPROVEMENTS  
AT THE LAMBS LANE WATER TREATMENT PLANT, AND APPROPRIATING  
\$510,000 THEREFOR, AUTHORIZED IN AND BY THE TOWNSHIP OF  
MANALAPAN, IN THE COUNTY OF MONMOUTH, NEW JERSEY.**

WHEREAS, the Township Committee of the Township of Manalapan, in the County of Monmouth, New Jersey (the "Township") has determined to provide for improvements to pressure filters located at the Lambs Lane Water Treatment Plant; and

WHEREAS, the Township has available \$510,000 in the Township's Water Capital Fund - Reserve for Capital Projects.

NOW, THEREFORE, BE IT ORDAINED by the TOWNSHIP COMMITTEE OF THE TOWNSHIP OF MANALAPAN, IN THE COUNTY OF MONMOUTH, STATE OF NEW JERSEY, AS FOLLOWS:

Section 1. The improvements described in Section 2 of this ordinance are hereby authorized as water capital improvements to be undertaken in and by the Township of Manalapan, in the County of Monmouth, New Jersey (the "Township"). For the improvements or purposes described in Section 2, there is hereby appropriated \$510,000, said sum being inclusive of \$510,000 in the Township's Water Capital Fund - Reserve for Capital Projects.

Section 2. The improvements hereby authorized to be undertaken consist of upgrades to the two (2) existing vertical pressure filters located at the Lambs Lane Water Treatment Plant, including, but not limited to, the installation of an air scour system, chemical storage tank modifications, the replacement of filter media, and the installation of flow meters, flow control valves and turbidimeters on each filter to allow for the regulation of flow through the filters, together with all purposes necessary, incidental or appurtenant thereto, all as shown on and in accordance with contracts, plans, specifications or requisitions therefor on file with or through the Township Clerk, as finally approved by the governing body of the Township.

Section 3. The 2017 capital budget of the Township will conform to the provisions of this ordinance to the extent of any inconsistency herewith. The resolution in the form promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director of the Division of Local Government Services is on file with the Township Clerk and is available there for public inspection.

Section 4. An aggregate amount not exceeding \$75,000 for interest on said obligations, costs of issuing said obligations, engineering costs, legal fees and other items of expense listed in and permitted under N.J.S.A. 40A:2-20 is included as part of the cost of said improvements and is included in the estimated cost indicated herein for said improvements.

Section 5. The Township Attorney and other Township officials and representatives are hereby authorized to do all things necessary to accomplish the purposes of the appropriation made herein.

Section 6. Any grant or similar moneys from time to time received by the Township for the purpose described in Section 2 hereof, shall be applied to direct payment or repayment to the Township of the cost of the improvements within the appropriation herein authorized.

Section 7. This ordinance shall take effect as provided by law.

**NOTICE OF PENDING CAPITAL ORDINANCE**

The capital ordinance, the summary terms of which are included herein, was introduced and passed upon first reading at a meeting of the governing body of the Township of Manalapan, in the County of Monmouth, New Jersey, held on **June 14, 2017**. It will be further considered for final passage after public hearing thereon, at a meeting of said governing body to be held in the Municipal Building, 120 Route 522 & Taylor's Mills Road, Manalapan, New Jersey, on **July 12, 2017**, at **8:00 p.m.**, or as soon thereafter as said matter can be reached, at which time and place all persons who may be interested therein will be given an opportunity to be heard concerning the same.

A copy of this ordinance has been posted on the bulletin board upon which public notices are customarily posted in the Township Hall of the Township during the week prior to and up to and including the date of such meeting; copies of the ordinance are available to the general public of the Township who shall request such copies, at the office of the Municipal Clerk in said Township of Manalapan, in the County of Monmouth, New Jersey. The summary of the terms of such capital ordinance follows:

**Purpose(s):** Providing for various upgrades to the two (2) existing vertical pressure filters located at the Lambs Lane Water Treatment Plant, including, but not limited to, the installation of an air scour system, chemical storage tank modifications, the replacement of filter media, and the installation of flow meters, flow control valves and turbidimeters on each filter to allow for the regulation of flow through the filters, together with all purposes necessary, incidental or appurtenant thereto.
