

**TOWNSHIP OF MANALAPAN**

**ORDINANCE NO. 2017-14**

**AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF MANALAPAN, COUNTY OF MONMOUTH, STATE OF NEW JERSEY, AMENDING THE ZONING MAP OF THE TOWNSHIP OF MANALAPAN TO REMOVE LOT 14.07 IN BLOCK 79, LOCATED ON STATE HIGHWAY NO. 33, FROM THE R-R RURAL RESIDENTIAL ZONING DISTRICT AND TO INCLUDE THAT PROPERTY IN THE C-3 GENERAL COMMERCIAL ZONING DISTRICT; AND TO REMOVE LOTS 14.06, 14.07, 14.08, 14.09 AND 14.10 IN BLOCK 82, LOCATED ALONG KINNEY ROAD, FROM THE PB ZONING DISTRICT AND TO INCLUDE THOSE PROPERTIES IN THE R-R ZONING DISTRICT.**

WHEREAS, the Township Zoning Officer has recommended that Lot 14.07 in Block 79, located on State Highway No. 33, be removed from the R-R Rural Residential zoning district and included in the C-3 General Commercial zoning district; and

WHEREAS, the Township Zoning Officer has recommended that Lots 14.06, 14.07, 14.08, 14.09 and 14.10 in Block 82, located along Kinney Road, be removed from the PB - Public Use zoning district and included in the R-R Rural Residential zoning district; and

WHEREAS, the aforesaid changes to the Zoning Map are in the best interests of the Township of Manalapan and its citizens;

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Manalapan, in the County of Monmouth, State of New Jersey, as follows:

SECTION ONE: Lot 14.07 in Block 79 on the Tax Assessment Map of the Township of Manalapan, located on State Highway No. 33, be and the same is hereby

removed from the R-R Rural Residential zoning district and included in the C-3 General Commercial zoning district.

SECTION TWO: Lots 14.06, 14.07, 14.08, 14.09 and 14.10 in Block 82 on the Tax Assessment Map of the Township of Manalapan, located along Kinney Road, be and the same are hereby removed from the PB - Public Use zoning district and included in the R-R Rural Residential zoning district.

SECTION THREE. All Ordinances or parts thereof inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistencies.

SECTION FOUR. If any section, subsection, paragraph, sentence or other portion of this Ordinance be adjudged by a Court of competent jurisdiction to be invalid, such judgment shall not affect, impair or invalidate the remainder of this Ordinance.

SECTION FIVE. This Ordinance shall take effect immediately upon its Passage and publication according to law and upon filing with the Monmouth County Planning Board.
