ORDINANCE NO. 2018-11

AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF MANALAPAN, COUNTY OF MONMOUTH, STATE OF NEW JERSEY, ADOPTING A ZONING MAP OF THE TOWNSHIP

WHEREAS, Section 95-5.1, "Zoning Map and Schedules," of the Code of the Township of Manalapan provides that the locations and boundaries of the zoning districts of the Township "are hereby established as shown on the Zoning Map" of the Township of Manalapan; and

WHEREAS, the Township Committee has previously adopted a Zoning Map dated October 12, 1998, which map has, from time to time, been amended and modified so as to revise the boundaries of certain Zoning Districts within the Township; and

WHEREAS, the Township Engineer has created a Zoning Map depicting all the existing Zoning District boundaries within the Township as of October 16, 2018; and

WHEREAS, the Township Committee now desires to adopt the aforesaid Zoning Map as prepared by the Township Engineer as the official Zoning Map of the Township of Manalapan;

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Manalapan, in the County of Monmouth, State of New Jersey, as follows:

SECTION ONE. The Zoning Map prepared by CME Associates, Township Engineer for the Township of Manalapan, depicting all existing zoning districts as of October 16, 2018 be and the same is hereby declared to be the official Zoning Map of the

Township of Manalapan. Copies of the Zoning Map shall be maintained on file in the office of the Township Clerk and in the Zoning Office.

SECTION TWO. All Ordinances or parts thereof inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistencies.

SECTION THREE. If any section, subsection, paragraph, sentence or other portion of this Ordinance be adjudged by a Court of competent jurisdiction to be invalid, such judgment shall not affect, impair or invalidate the remainder of this Ordinance.

SECTION FOUR. This Ordinance shall take effect immediately upon its passage and publication according to law and upon filing with the Monmouth County Planning Board.
