## TOWNSHIP OF MANALAPAN

## ORDINANCE NO. 2018-12

AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 234, "WATER", OF THE CODE OF THE TOWNSHIP OF MANALAPAN, SECTION 234-5, "METERING; WATER RATES", PERTAINING TO THE FEES, CHARGES AND RATES TO BE CHARGED FOR THE CONSUMPTION OF METERED WATER.

WHEREAS, the New Jersey Board of Public utilities on November 19,2018 approved a water rate increase off 8% for SUEZ Water Matchaponix; and

WHEREAS, under the Agreement for Public/Private Partnership and Operation, Maintenance and Management Services for the Manalapan Township Water Service Area between the Township and SUEZ, a portion of that rate increase is required to be passed through to the rates charged customers of the Township water system; and

WHEREAS, an increase of 4.28% to the current rates is therefore required;

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Manalapan in the County of Monmouth, State of New Jersey, as follows:

SECTION ONE. Chapter 234, "Water", of the Code of the Township of Manalapan, Section 234-5, "Metering; Water Rates." subsection 234-5C, "Fees for Metered Water" be and the same is hereby amended to read, in full, as follows:

"C. Fees for metered water. The Township shall, as circumstances require fix all fees, charges and rates as herein provided: As of March 1, 2019, the following annual rates shall be charged for the consumption of metered water to all consumers of the Township water system as set forth in Schedule A, attached hereto."

SECTION TWO. All Ordinances or parts thereof inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistencies.

SECTION THREE. If any section, subsection, paragraph, sentence or other portion of this Ordinance be adjudged by a Court of competent jurisdiction to be invalid, such judgment shall not affect, impair or invalidate the remainder of this Ordinance.

SECTION FOUR. This Ordinance shall take effect immediately upon its passage and publication according to law.
