

TOWNSHIP OF MANALAPAN

ORDINANCE NO. 2020 -21

AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF MANALAPAN, IN THE COUNTY OF MONMOUTH, STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING CHAPTER 226, "VEHICLES AND TRAFFIC", SECTION 226-68, "SCHEDULE X: SPEED LIMITS", OF THE CODE OF THE TOWNSHIP OF MANALAPAN, ESTABLISHING A SPEED LIMIT ON TRACY STATION ROAD.

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Manalapan, County of Monmouth and State of New Jersey, as follows:

Section 1. Chapter 226 entitled, "Vehicles and Traffic," of the Code of the Township of Manalapan, Section 226-68, Schedule X, entitled "Speed Limits," is hereby amended and supplemented to add thereto the following location:

<u>Name of Street</u>	<u>M.P.H.</u>	<u>Location</u>
"Tracy Station Road	35	From the Englishtown border to the Monroe border for its entire length in Manalapan"

Section 2. All Ordinances or parts thereof inconsistent with the provisions of this Ordinance be and the same are hereby repealed to the extent of such inconsistencies.

Section 3. Should any section, paragraph, clause of any other portion of this Ordinance be adjudged by a Court of competent jurisdiction to be invalid, such judgment shall not effect or impair the remainder of this Ordinance.

Section 4. This Ordinance shall take effect upon its passage and publication according to law and upon submission of a certified copy of the same to the New Jersey Department of Transportation.
