**NOTICE OF PUBLIC HEARING**

**PROPOSED AMENDMENT TO THE  
MONMOUTH COUNTY SOLID WASTE PLAN**

In accordance with the requirements of the New Jersey Solid Waste Management Act (N.J.S.A. 13:1E-1 et seq), the Monmouth County Board of Chosen Freeholders will be holding a public hearing on Thursday, March 9, 2017, at 1:00 p.m., or as soon thereafter as the matter may be heard, at the Monmouth County Hall of Records, Freeholders Meeting Room, second floor, One East Main Street, in Freehold, New Jersey.

The purpose of this hearing is to hear persons interested in, or who would be affected by, a proposed amendment to the Monmouth County Solid Waste Plan entitled "Proposed Expansion of the Class B Recycling Center at Gold Star Recycling, Inc., 133 Amboy Road, Marlboro", which would allow the expansion of Gold Star Recycling, Inc. to apply to the New Jersey Department of Environmental Protection (NJDEP) for expansion of the facility to increase the amount of recyclable concrete, brick, block, asphalt, and stone from 300 tons per day or 1,500 tons per week to a maximum of 800 tons per day with a weekly tonnage of 3,000 tons per week at its existing office and construction yard located at Block 178; Lots 297 and 298, comprising 9.95 acres on Amboy Road at the cited address. This Class B Recycling Center would be allowed to operate Monday through Friday from 7:00 a.m. until 5:00 p.m., and on Saturdays from 7:00 a.m. until 12:00 p.m. Any person may appear at this hearing in person, or by agent, or by attorney.

Copies of this proposed amendment have been distributed to each municipality in Monmouth County via electronic mail, and have also been distributed to each branch of the Monmouth County Library System. Copies are additionally available on request to the Monmouth County Solid Waste Coordinator at the Monmouth County Reclamation Center. Any written comments should be directed to the Solid Waste Coordinator, c/o Monmouth County Reclamation Center, 6000 Asbury Avenue, Tinton Falls, New Jersey, 07753. Comments received on or before March 17, 2017 will be appended to the official Public Hearing Transcript that will be sent to the NJDEP Commissioner.
