

**TOWNSHIP OF MANALAPAN
ORDINANCE NO. 2019-07**

**AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF
MANALAPAN, COUNTY OF MONMOUTH, STATE OF NEW JERSEY, AMENDING AND
SUPPLEMENTING CHAPTER 110, "FIRE PREVENTION," ARTICLE II, "UNIFORM
FIRE CODE ENFORCEMENT," SECTIONS 110-13, "PERMIT FEES," AND SECTION
110-14, "CERTIFICATE AND MISCELLANEOUS FEES," PROVIDING FOR REVISIONS
TO INSPECTION FEES FOR NON-LIFE HAZARD USE INSPECTIONS**

BE IT ORDAINED by the Township Committee of the Township of Manalapan, in the County of Monmouth, State of New Jersey, as follows:

Section I. Section 110-13, "Permit Fees" and Section 110-14, "Certificate And Miscellaneous Fees," of Chapter 100, "Fire Prevention," of the Code of the Township of Manalapan, be and the same are hereby amended and supplemented to read, in full, as follows:

"Section 110-13 Permit Fees. The fee for a construction permit shall be the sum of the subcode fees listed in the Subsections A through E hereof and shall be paid before the permit is issued.

"§ 110-13. Permit Fees

a. Fees shall be in accordance with the Uniform Fire Code, and any amendments thereto.

b. The inspection fees for all non-life hazard use inspections in accordance with §110-12 hereof, are as follows:

(1) Assembly

(7) Commercial Common Areas

All Shopping Centers, Strip Malls, Office Buildings, Office Complexes, Industrial Parks, and other commercial complexes that share common areas including but not limited to Corridors, atriums, stairwells, fire protections systems (fire sprinklers, private fire hydrants, private fire water

mains and fire alarms) parking lots and fire lanes.

Fee Per Year

(8) Sub-leased and Shared Space

Any party that sub-leases such property or shares space with another party is required to pay fees as in the above tables based on the actual square footage used. In such instances where the actual square footage used is 499 square feet or less, the fee shall be [~~\$ 30.00~~] **\$35.**

C. Uses not classified that are subject to the Uniform Fire Code shall be classified as business uses.

D. At the Fire Official's discretion, vacant buildings may be inspected and such fees shall be required according to the previous use of such buildings.

E. The inspection fee shall be paid to the Township annually by the individual, firm or corporation, as the case may be.

F. The permit and registration fees as established by the Uniform Fire Code, except as amended in this section, and as amended from time to time pursuant to N.J.A.C. Chapter 5 shall remain in full force and effect as set forth therein.

110-14. Certificate and Miscellaneous Fees

a. The fee for the issuance of a Certificate of Fire Code Status shall be [~~\$45.00~~] **\$55.**

b. The fee for fire reports shall be [~~\$20.00~~] **\$25.**

c. The fee for photographs shall be [~~\$7.00~~] **\$9.00** per photograph **or cost of CD.**

d. The fee for the Certificate of Smoke Detector and Carbon Monoxide Alarm Compliance shall be [~~\$45~~] **\$55.00.**”

SECTION THREE. All Ordinances or parts thereof inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

SECTION FOUR. Should any section, paragraph, clause or other portion of this Ordinance be adjudged by a Court of competent jurisdiction to be invalid, such judgment shall not affect or impair the remainder of this Ordinance.

SECTION FIVE. This Ordinance shall take effect upon its passage and publication according to law.

NOTICE OF PUBLIC HEARING

The Ordinance published herewith was Introduced and approved at a meeting of the Township Committee of the Township of Manalapan held on March 27, 2019. This Ordinance will be further considered for final passage after a Public Hearing thereon before the Township Committee of the Township of Manalapan during a meeting to be held on April 10, 2019 at the Municipal Complex, 120 Route 522 and Taylors Mills Road, Manalapan, New Jersey at 7:30 p.m. or as soon thereafter as the matter may be reached, or at any meeting to which that meeting may be adjourned, at which time any and all persons who may be interested therein will be given an opportunity to be heard.
