PLANNING BOARD/ZONING BOARD OF ADJUSTMENT PUBLIC NOTICING AND PUBLIC HEARING PROCEDURE

1. Public Noticing:

- A. Complete the Public Hearing Notice form.
- In the "SECTION NO." portion of the form, write or type in the Zoning Officer's handwritten comments from your application noted on page 2 in "Variation of Section No."
- In the "REASON" section, write or type in the proposed work and cite the Zoning Officer's handwritten denial that is stated in "Denial of Zoning Certification" on the variance application form. Make copies of the form, leaving the addresses section blank.
 - ****Please be sure to include the bold language underscored at the bottom of this section*****
- B. Write in each of the property owners noted on your certified list, including county agencies.
- C. Notices must be postmarked a minimum of 11 days prior to the Public Hearing Date.

2. Advertise Notice in the Newspaper:

- A. Notice must be published in the Asbury Park Press a minimum of <u>11 days</u> prior to the Public Hearing date. The same form that was used for your certified mailings may be used for the ad.

Prior to the Public Hearing:

The following items must be submitted to the Zoning office a minimum of five days prior to the Public Hearing date:

- a. Original certified receipts from the Post Office:
- b. A copy of the Notice that was mailed out to the certified list of property owners;
- c. Original Affidavit of Publication from the Asbury Park Press; and
- d. A notarized Affidavit of Service form (attached). The form will be signed and notarized after Notices are mailed out from the Post Office.

<u>Public Hearing:</u>

Attend the Public Hearing on the date provided to you by the Zoning Board of Adjustment at 7:30 virtually at HD OfficeSuite.

Typically, a verbal vote is taken by the Board. A Resolution of the Board's decision will be memorialized and signed no later than 45 days after your Hearing Date. You will be sent an original, signed Resolution. Applicant must advertise the Resolution of approval in the Asbury Park Press.
