

**TOWNSHIP OF MANALAPAN**

**ORDINANCE NO. 2022 -14**

**AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF MANALAPAN, IN THE COUNTY OF MONMOUTH, STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING CHAPTER 226 "VEHICLES AND TRAFFIC" OF THE CODE OF THE TOWNSHIP OF MANALAPAN, EXCLUDING TRUCKS OVER FOUR TONS REGISTERED GROSS WEIGHT FROM A PORTION OF UNION HILL ROAD.**

**NOW, THEREFORE, BE IT ORDAINED** by the Township Committee of the Township of Manalapan, County of Monmouth and State of New Jersey, as follows:

**SECTION 1.** Chapter 226 entitled, "Vehicles and Traffic", of the Code of the Township of Manalapan, Section 226-63, Schedule V, entitled "Trucks Over Certain Weight Excluded", subsection 226-63A, which excludes trucks over four tons registered gross weight from certain streets, is hereby amended and supplemented to add thereto the following location:

<u>Name of Street</u>	<u>Location</u>
"Union Hill Road	Pension Road to Marlboro Border"

**SECTION 2.** All Ordinances or parts thereof inconsistent with the provisions of this Ordinance be and the same are hereby repealed to the extent of such inconsistencies.

**SECTION 3.** Should any section, paragraph, clause of any other portion of this Ordinance be adjudged by a Court of competent jurisdiction to be invalid, such judgment shall not effect or impair the remainder of this Ordinance.

**SECTION 4.** This Ordinance shall take effect upon its passage and publication according to law and upon passage by the Township of Marlboro of an Ordinance excluding trucks over four tons registered gross weight from Union Hill Road from the Marlboro border to State Highway No. 9.
