Each application must be accompanied by a check for \$100.00 as the initial application fee and license for one year. This fee is non-refundable. Each successive year's fee will be \$25.00.

Within ten (10) days of the granting of the license the licensee shall be required to post a ten thousand dollar (\$10,000.00) Bond with the Township as required by Section 6 of Chapter 173. Said Bond shall contain the following language: "THE OBLIGATION OF THIS BOND SHALL, IN ADDITION TO THE TOWNSHIP OF MANALAPAN, BE AND REMAIN FOR THE BENEFIT OF ANY PERSON WHO SHALL OBTAIN A JUDGEMENT AGAINST THE OBLIGOR AS A RESULT OF DAMAGE SUSTAINED IN OPERATION PURSUANT TO ANY LICENSE GRANTED UNDER TOWNSHIP ORDINANCE."

Said Bond shall be kept in force for a minimum period of one (1) year from date of issuance of the license and must be renewed annually along with the license.

NOTE: Every applicant should familiarize his/her self with the penalty section under Section 8 of Chapter 173.
