TO OUR CUSTOMERS:

PLEASE TAKE NOTICE that on March 16, 2023, Jersey Central Power & Light Company ("JCP&L" or "Company"), filed a petition with the New Jersey Board of Public Utilities ("Board"), seeking approval of proposed overall increases in and/or other adjustments to JCP&L's various tariff rates and charges for electric service, and for approval of other proposed Tariff charges and revisions, which were proposed to become effective for service rendered on and after April26, 2023, or at such later date as the Board may determine.

On August 7, 2023, the Company updated its petition based on 12 months of actual data. As a result of this update, the proposed new rates would yield an overall net operating revenue increase of approximately \$192.2 million, representing an overall revenue increase of about 7.2% as compared to the same current annualized tariff rates and revenues. The annual percentage increase applicable to specific customers will vary according to the applicable rate schedule and the level of the customer's usage. As proposed, a typical JCP&L residential customer using 777 kWh per month currently paying, on average, \$112.83, will experience an increase to \$121.56 per month, resulting in a monthly increase of \$8.73 or 7.7%.

Please note that the Board in its discretion may apply all or any portion of whatever rate increases the Board may ultimately allow to other rate schedules or in a different manner than what JCP&L has proposed in its filings. Accordingly, the final rates and charges to be determined by the Board in this proceeding may be different than what JCP&L has described herein.
