NOTICE TO BIDDERS

SALE OF A PLENARY RETAIL DISTRIBUTION ("D") LICENSE

NOTICE IS HEREBY GIVEN that separate sealed bids will be received by the Township Committee of the Township of Manalapan, Monmouth County, State of New Jersey for the issuance of one (1) new plenary retail distribution license, as more particularly described in the Specifications and Bid Proposal Form(s).

All bids shall be delivered to the Township Clerk, Township of Manalapan, Manalapan Municipal Building, 120 Route 522, Manalapan, New Jersey 07726. All bids will be opened and read in public at the Meeting Room, Manalapan Municipal Building, 120 Route 522, Manalapan, New Jersey, on Friday, July 19, 2024, at 10:00 A.M., prevailing time.

Specifications for the issuance of the plenary retail distribution license are posted on the Township's website, https://mtnj.org, on file in the Township Clerk's office, Manalapan Municipal Building, 120 Route 522, Manalapan, New Jersey 07726, and copies thereof and the form of proposal may be obtained during regular business hours by prospective bidders upon application to the Township Clerk.

<u>Pre-Qualification</u>. Each prospective bidder must submit, in a sealed envelope, a pre-bid qualification package to the Township Clerk in the manner designated therein and in accordance with the Specifications no later than Friday, June 14, 2024 by 10:00

A.M., prevailing time. All pre-bid qualification packages shall contain a completed Pre-Qualification Form; a completed person to person alcoholic beverage license transfer application, together with the annual two-thousand five hundred (\$2,500.00) dollar license fee; and a certification that all parties in interest satisfy the requirements of the New Jersey Alcoholic Beverage Law and Regulations and are qualified to hold an alcoholic beverage license. All pre-bid application packages shall be opened and read in public on Friday, June 14, 2024 at 10:00 A.M., prevailing time, at the Meeting Room, Manalapan Municipal Building, 120 Route 522, Manalapan, New Jersey 07726.

<u>Submission of Bids</u>. Each bidder who has pre-qualified shall deliver a separate sealed bid package containing the actual bid proposal form together with a Bank Check, Cashier's Check or Money Order in the amount of ten (10%) percent of the total bid amount, and a Commercial Domestic Letter of Credit for the balance of the total bid amount no later than 10:00 A.M., prevailing time on Friday, July 19, 2024, at the Manalapan Municipal Building, 120 Route 522, Manalapan, New Jersey 07726.

The Township Clerk will only open sealed bids from those bidders who have satisfied the pre-qualification requirements.

In addition, the successful bidder will be subject to investigation by the Manalapan Township Police Department and, if found not to be qualified, shall forfeit the two-thousand five hundred (\$2,500.00) dollar license fee to the Township of Manalapan to cover the cost of the police investigation. If the bidder is qualified, the two-thousand five hundred (\$2,500.00) dollar payment will serve as the fee for the first annual license

term or portion thereof. The Township will return the ten (10%) percent deposit to any bidder who fails to qualify to hold an alcoholic beverage license.

The Township Committee of the Township of Manalapan reserves the right to waive any informality in the bidding, the right to reject all bids if the highest bid is not accepted, and the right to reject any and all bids as deemed to be in the best interests of the Township to do so, and reserves the right to hold the bids and proposal guarantees of the two highest bidders for ninety (90) days before making an award of the new plenary retail distribution license and each bidder agrees that he will not withdraw his bid for that period of time.

SPECIFICATIONS FOR ONE (1) PLENARY RETAIL DISTRIBUTION LICENSE TO BE ISSUED BY AND USED WITHIN THE TOWNSHIP OF MANALAPAN

1. GENERAL STATEMENT.

The Township Committee of the Township of Manalapan has authorized the issuance of one (1) new plenary retail distribution license. Said plenary retail distribution license can only be used for the sale of alcoholic beverages in original containers for consumption off the licensed premises.

2. MINIMUM BID.

The minimum bid for the aforesaid plenary retail distribution license shall be eight hundred fifty thousand (\$850,000.00) dollars. No bid of less than that amount shall be accepted.

3. BASIS OF AWARD.

The aforesaid license shall be issued to the highest qualified bidder pursuant to the Specifications and N.J.S.A. 33:1-1 *et seq.* and N.J.A.C. 13:2-2 *et seq.* The Township of Manalapan specifically reserves the right to reject all bids if the highest bid is not accepted, to reject all bids if deemed in the best interests of the Township so to do, and to hold the bids and guarantees of the two (2) highest bidders for a period of ninety (90) days before making an award to the highest qualified bidder, subject to the results of investigation by the Manalapan Township Police Department.

4. PAYMENT OF PURCHASE PRICE.

The successful bidder shall pay the total purchase price as follows:

A. A deposit of ten (10%) percent of the total bid price must be submitted with the bid package by each bidder. The Township will return the ten (10%)

- deposit to any bidder who fails to qualify to hold an alcoholic beverage license.
- B. An additional fifteen (15%) percent of the total purchase price shall be paid within seven (7) days of the determination that the bidder is the apparent highest bidder.
- C. The remaining seventy-five (75%) of the total purchase price shall be paid within fifteen (15) days of completion of the Police Department investigation finding that the bidder is qualified to hold an alcoholic beverage license.

5. SUBMISSION OF PRE-BID QUALIFICATION PACKAGE.

Each prospective bidder shall submit a pre-bid qualification package in a sealed envelope marked "Distribution License Pre-qualification Package" to the Township Clerk of the Township of Manalapan, 120 Route 522, Manalapan, New Jersey, no later than 10:00 A.M., prevailing time, on June 14, 2024. All pre-qualification packages shall be opened and read in public at that time in the Meeting Room, Manalapan Municipal Building.

The pre-qualification package shall contain:

- 1. A completed Pre-Qualification Form which includes a certification that the bidder and all parties in interest named in the application satisfy the requirements of the Alcoholic Beverage Law and Regulations and are qualified to hold an alcoholic beverage license.
- 2. A completed application for a person to person transfer of an alcoholic beverage license.
- 3. A bank check, cashier's check or a money order, payable to "The Township of Manalapan" in the amount of two-thousand five hundred (\$2,500.00) dollars

representing the annual license fee for the first license term or portion thereof of the new plenary retail distribution license.

Only those prospective bidders who satisfy the pre-qualification requirements will be eligible to submit a bid for the purchase of the license on July 19, 2024.

6. **SUBMISSION OF BID.**

Each pre-qualified bidder shall submit a bid package in a sealed envelope marked "Distribution License Bid" to the Township Administrator of the Township of Manalapan, Manalapan Municipal Building, 120 Route 522, Manalapan, New Jersey, no later than 10:00 A.M., prevailing time, on July 19, 2024. All bids shall be opened and read in public at that time in the Meeting Room, Manalapan Municipal Building.

Each bid package shall contain:

- 1. The completed Bid Proposal Form.
- 2. A bank check, cashier's check or money order in the amount of 10% of the bid, made payable to "The Township of Manalapan".
- A Commercial Domestic Letter of Credit issued to the Township of Manalapan by a commercial bank for the balance of the total bid amount.

7. POLICE INVESTIGATION PRIOR TO AWARD OF LICENSE TO HIGHEST QUALIFIED BIDDER.

The two (2) apparent highest qualified bidders will be investigated by the Manalapan Township Police Department and, if found not to be qualified to hold an alcoholic beverage license, shall forfeit the two-thousand five hundred (\$2,500.00) dollar license fee to cover the cost of the police investigation. The Township will return the 10% down payment of the purchase price submitted with the bid of any bidder who fails to qualify to hold an alcoholic beverage license. In the event that a bidder is found to be qualified and is awarded the license, the \$2,500.00 will serve as the first annual license term fee or portion thereof.

8. PLACE TO PLACE TRANSFER APPROVAL AND COMPLIANCE WITH ZONING AND OTHER REQUIREMENTS.

The successful bidder shall obtain the approval of the Township Committee of the Township of Manalapan for a place to place transfer of the plenary retail distribution license prior to the use of the license, and shall comply with all applicable Township zoning regulations and ordinances and/or other applicable laws. The Township Committee has considered the substantial population growth occurring in Manalapan along the State Highway 33 corridor and would prefer to locate the additional distribution license in that area.

9. AMENDMENTS TO SPECIFICATIONS.

Should any amendments, modifications or clarifications to the specifications be required, all such changes to the specifications will be issued in the form of an Addendum to the bidding documents. A copy of any Addendum to the bidding documents will be mailed, telefaxed or emailed to any prospective bidder who has obtained a copy of the Bid Proposal and Specifications. Notice of the issuance of any Addendum will also be published at least five (5) days prior to the date scheduled for receipt of bids.

All prospective bidders are hereby notified that no verbal representations may be relied upon with respect to the Specifications and that only a formal Addendum will be sufficient to alter or modify the terms and conditions of the Specifications. Any deviation which the bidder proposes to the terms and conditions of the Specifications should be noted in writing and submitted with the Bid Proposal form. A determination will be made by the Township Committee of the Township of Manalapan as to whether any such

deviation is material. Any material deviation from the terms and conditions of the Specifications will result in the rejection of the bid.

10. **BINDING NATURE**.

These Specifications shall be binding upon the parties hereto their heirs, executors, administrators, successors and assigns.
