ORDINANCE NO. 2025-14

AN ORDINANCE FURTHER AMENDING CHAPTER 96, "GAITWAY REDEVELOPMENT AREA," SECTION 96-2, "ADOPTION OF REDEVELOPMENT PLAN," OF THE CODE OF THE TOWNSHIP OF MANALAPAN, AMENDING AND SUPPLEMENTING SECTION 2, "DEVELOPMENT STANDARDS", SUBSECTION 2.2, "PERMITTED PRINCIPAL USES", OF THE GAITWAY REDVELOPMENT PLAN

WHEREAS, on the December 22, 2021, the Township Committee of the Township of Manalapan adopted Chapter 96, "Gaitway Redevelopment Area," of the Code of the Township of Manalapan and adopted the Gaitway Redevelopment Plan to regulate development in that area; and

WHEREAS, the Gaitway Redevelopment Plan was amended by Ordinance No. 2022-06, finally adopted on April 27, 2022; by Ordinance No. 2022-12, finally adopted on July 13, 2022 and by Ordinance No. 2024-12, finally adopted on May 22, 2024; and

WHEREAS, the Township Committee wishes to further amend the plan to expand the permitted uses in the Redevelopment Area;

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Manalapan, County of Monmouth in the State of New Jersey as follows:

SECTION 1. Chapter 96, "Gaitway Redevelopment Area", of the Code of the Township of Manalapan, Section 96-2, "Adoption of Redevelopment Plan," be and the same is hereby amended and supplemented by the addition thereto of subsection 96-2C, subparagraph C.2. to read as follows:

"C.2. Section 2.2, "Permitted Principal Uses", of the Gaitway Redevelopment Plan", adopted on December 22, 2021, be and the same is hereby amended and supplemented to read, in full, as follows:

2.2. Permitted Principal Uses

1. Light Industrial Uses

- a. Light manufacturing
- b. Fabrication
- c. Assembly
- 2. Warehousing and Storage, including refrigerated
- 3. Distribution Facilities, not including Last Mile Distribution Facilities
- Wholesaling
- 5. Scientific or Research Facilities¹
- 6. Indoor and outdoor agriculture, including the raising and training of horses, but excluding marijuana cultivation
- 7. Indoor Recreation Centers, including indoor and outdoor ice skating/hockey rinks per requirements of Section 95-6.17 and subject to the lot area and building requirements established in the SED-5 Zoning District, and yard and building height requirements per Table 2 of this Plan.
- 8. Any combination of the above listed permitted uses may be located within a single building, or within a group of buildings.
- 9. Restaurant, Category One
- 10. Restaurant, Category Two
- 11. Bars
- 12. Medical and dental offices, including physical and occupational therapy
- 13. Personal services, including hair and nail salons
- 14. Spa
- 15. Professional offices
- 16. Banks
- 17. Retail, except grocery stores, convenience stores and pharmacies
- 18. Indoor athletic, exercise or recreation facilities
- 19. Indoor sports and recreation centers, including pickleball, trampoline and climbing wall facilities, batting cages, escape and video game rooms.
- 20. Indoor golf training facility
- 21. Fitness/health club
- 22. Instructional and tutoring services"

SECTION 2. All Ordinances, or parts thereof, inconsistent with the provisions of this

Ordinance shall be and the same are hereby repealed to the extent of such inconsistency.

SECTION 3. Should any section, paragraph, clause or other portion of this Ordinance

be adjudged by a court of competent jurisdiction to be invalid, such judgement shall not affect or

impair the remainder of this Ordinance.

SECTION 4. A copy of this Ordinance and the Redevelopment Plan, as amended, shall

be available for public inspection at the office of the Township Clerk during regular business

hours.

SECTION 5. This Ordinance shall become effective upon its passage and publication

according to law, and upon filing of a certified copy thereof with the Monmouth County Planning

Board.
