ORDINANCE 2025-18

AN ORDINANCE OF THE TOWNSHIP OF MANALAPAN AMENDING AND SUPPLEMENTING CHAPTER 163, "PARKS AND RECREATION AREAS", OF THE CODE OF THE TOWNSHIP OF MANALAPAN, ARTICLE II, "RULES AND REGULATIONS", SECTION 163-4, "PROHIBITED ACTIVITIES", PERTAINING TO THE USE OF ELECTRIC VEHICLES IN PARKS AND RECREATION AREAS.

BE IT ORDAINED, by the Township Committee of the Township of Manalapan, in the County of Monmouth, and State of New Jersey as follows:

Section 1. Chapter 163, "Parks and Recreation Areas", of the Code of the Township of Manalapan, Article II, "Rules and Regulations", Section 163-4, "Prohibited Activities", be and the same is hereby amended and supplemented to add a new subparagraph (38) to read, in full, as follows:

"(38) Restrictions on use of electric vehicles.

- (a) No person shall use, operate, drive, or ride an electric vehicle, including a low speed electric bicycle, moped, scooter, hoverboard, or segway on any unpaved surface in any park or recreation area.
- (b) No person shall use, operate, drive, ride in or upon, or permit the use, operation or riding of an electric vehicle in the Manalapan Recreation Center during the day designated as Manalapan Day each year."

Section 2. All Ordinances or parts of ordinances inconsistent with this Ordinance are thereby repealed to the extent of such inconsistency.

Section 3. If any section, subsection, paragraph, sentence, or other portion of this Ordinance be adjudged by a Court of competent jurisdiction to be invalid, such judgment shall not affect, impair or invalidate the remainder of this Ordinance.

Section 4. This Ordinance shall take effect upon its passage and publication according to law.
