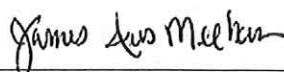
PLEASE TAKE NOTICE that the Board has scheduled a public hearing on this matter at the times set forth in the enclosed Public Notice.

NOTICE OF PUBLIC HEARING

In the Matter of the Verified Petition of Jersey Central Power & Light Company Seeking Review and Approval of Its Deferred Balances Relating to, and an Adjustment of, the Societal Benefits Charge Clause of Its Filed Tariff ("2024 SBC Filing")

PLEASE TAKE NOTICE that, on April 1, 2025, Jersey Central Power & Light Company ("JCP&L" or "Company") filed a Verified Petition with the New Jersey Board of Public Utilities ("Board") for the review and approval of the deferred balances accumulated with respect to the Demand Side Factor ("DSF") and Uncollectible Accounts Charge ("UNC") components of the Company's Societal Benefits Charge ("SBC"), to the extent accumulated for each from January 1, 2024, through December 31, 2024 ("Petition").

If approved, the proposed changes to the components of the Rider SBC would result in an overall increase to the composite Rider SBC rate from \$0.008666 per kilowatt-hour ("kWh"), exclusive of Sales and Use Tax ("SUT"), to \$0.008688 per kWh, exclusive of SUT, and would result in an increase to the monthly bill of a typical residential customer using 777 kWh per month of \$0.02, or 0.01%, from a current bill of \$163.52 per month to \$163.54 per month based on the proposed Rider SBC and other rates effective as of October 1, 2025, including SUT.

The following illustrative chart shows the estimated monthly bill impacts, in both dollars and percentages, to residential customers of various usage levels and to overall average customers of all rate classes based upon a comparison of current and proposed rates and the approximate net effect of the proposed increases. For the "Residential Average Bill," the "Current Monthly Bill" is calculated using the product of the customer's usage at the stated level multiplied by all applicable rates in effect as of October 1, 2025, by season and block during the 12-month period, including the monthly fixed customer charge, divided by 12. For "Overall Class Average Per Customer," the "Current Monthly Bill" is calculated using the product of all customers' total usage in each class multiplied by all applicable current rates that are in effect as of October 1, 2025, by season and block (if applicable), including monthly fixed customer charges (fixture charges for the lighting class) during the 12-month period, divided by the number of customers and months in that class. The "Proposed Monthly Bill" for both "Residential" and "Overall Class Average" customers are calculated in the same manner, except that the proposed SBC rate is used instead of the current SBC rate. The total amount of the requested increase is approximately \$416,000 annually. The actual effect on specific customers will vary according to the applicable rate schedule and level of the customer's usage.
