AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF MANALAPAN, IN THE COUNTY OF MONMOUTH, STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING CHAPTER 226 "VEHICLES AND TRAFFIC" OF THE CODE OF THE TOWNSHIP OF MANALAPAN, LIMITING PARKING IN THE MUNICIPAL BUILDING PARKING LOT AND PROVIDING FOR A NO STOPPING AND STANDING ZONE ON ROUTE 522

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Manalapan, County of Monmouth and State of New Jersey, as follows:

Section One. Chapter 226 entitled, "Vehicles and Traffic", of the Code of the Township of Manalapan, Section 226-8, "Parking time limited", Schedule II (§ 226-61) which limits parking during certain times be and is hereby amended and supplemented to add thereto the following streets or parts of streets where parking is limited:

Name of Street	Side	Time Limit/Hours	Location
"Municipal Complex	Both	Parking limited to non-Court official municipal business only	Parking lot in front of Municipal Building
Municipal Complex		Parking limited to official municipal business only	Parking lots in front of post office and on north side of Municipal Building"

Appropriate signage shall be installed.

Section Two. Chapter 226 entitled, "Vehicles and Traffic", of the Code of the Township of Manalapan, Section 226-10, "Stopping or Standing in Fire Zone or Lane", be and the same is hereby amended and supplemented to read, in full, as follows:

"§226-10. Stopping or standing prohibited.

- A. No person shall stop or stand a vehicle in such a manner as to obstruct a fire lane, fire zone or a fire hydrant.
- B. No person shall stop or stand a vehicle upon any of the following streets or parts of streets during the hours specified:

Name of Street	Side	Location	Hours
County Route No. 522	Both	From mile marker 2.5 to the Englishtown line	All"

Section Three. All Ordinances or parts thereof inconsistent with the provisions of this Ordinance be and the same are hereby repealed to the extent of such inconsistencies.

Section Four. Should any section, paragraph, clause of any other portion of this Ordinance be adjudged by a Court of competent jurisdiction to be invalid, such judgment shall not effect or impair the remainder of this Ordinance.

Section Five. This Ordinance shall take effect immediately upon its passage and publication according to law.
